RULES

- 1.1 The Organizing Authority for this regatta is Birmingham Sailing Club.
- 1.2 The regatta will be governed by the rules as defined in The Racing Rules of Sailing. Measurement requirements do not apply.

2. ELIGIBILITY AND ENTRY

- 2.1 Applicants for all classes must be rising high school seniors or younger at the start of the regatta.
- 2.2 Competitors are required to supply their own boats.

2.3 Membership in US Sailing is required for each competitor (helmsman and crew for doublehanded classes). Sailors can join online at www.ussailing.org/membership.

4. Sailing Instructions

5. Scoring –

5.1 The Low-Point Scoring System, Appendix A2 of the RRS shall apply.
5.2 As many races as possible will be sailed. At least one race must be completed to constitute a Series. If seven or more races are sailed, a boat's worst score will be discarded.

6. Lifejackets

6.1 All competitors shall wear, while on the water, a U.S. Coast Guard approved PFD, except for brief periods while removing or adding clothing. 6.2 Each competitor shall have a whistle attached to their PFD at all times while on the water.
